By signing below, you agree that you are volunteering or providing community service on your own behalf without the expectation of financial compensation.

You agree to indemnify, release, and hold harmless the City of Wilmington, its officials, officers, employees, agents, representatives, and assigns from any and all claims, demands, injuries, suits, settlements, judgments, or actions of any kind arising from or related to, in any factual or logical basis, you volunteering or community service with the City of Wilmington, including but not limited to property damage, personal injury, or death. The aforementioned indemnification and hold harmless shall include the payment of all related expenses, costs, expert witnesses, attorney's fees, and consultant fees associated with an indemnified event.

You acknowledge that you understand all of the risks and hazards associated with your volunteering or community service with the City of Wilmington, and you assume all risk of loss, damage, or injury, including death, that may be sustained while performing such volunteering or community service.

This agreement shall be binding on the heirs, executors, administrators, legal representatives, successors, and assigns of the undersigned.
