Year in Review: Public Works Snapshot




- Created 220+ MG of drinking Water
- Treated 356 MG of Wastewater
- Flushed/inspected 700+ Fire Hydrants, Painted 244
 Hydrants
- Completed 1000+ Utility Locates

Created & Completed & Tracked 370 Work Orders (since May)

- 5 Water Main Break Repairs, 11 Water Service Leak Repairs
- 7 Lead Service Replacements
- 35 Buffalo Box Replacement/Repairs
- 35 Sewer Cleanings
- Salted/Plowed over 250 Plow Miles of Road on 10 different occasions
- 26 Signs Replaced
- 50 Road and Sidewalk Improvements/Repairs
- 4 Sidewalk Share Programs Completed
- 20 Equipment/Vehicle Serviced
- 262 Residential Meters and 37 Commercial Meters Replaced

System Improvements

- Installation of i-Hydrants.
- Improved billing software and increased adoption of automatic billing.
- Replaced roof and structure at the water treatment plant.
- · New water meter truck.
- Water system leak detection performed.



2 Years Ago

- Over 450 estimated water bills.
- ~40-52% water produced was accounted for.
- All users were paying same meter replacement fee.
- Large water meters were not being certified or calibrated.

Today

- Less than 30 estimated water bills.
- ~75% of water produced is accounted for.
- Users are paying actual costs to replace their specific meters.
- Large water meters have been certified and will be re-checked and calibrated as recommended.

Regional Water Issues


- All our neighboring communities are having to deal with large, expensive generational water issues.
- Ground wells will be critically low by 2030.
- Wilmington is the only freshwater system in the area.
- We must continue to invest and maintain.
- Wilmington has over 93 miles of water main.

Monthly Status Report - December 2022

Honorable Mayor Dietz and City Council Members Chief Adam Zink

During the month the patrol division had the following activity:

- · 5 Pedestrian/Suspicious Stops were conducted
- · 165 Business (Walk and Talk) Checks (officers entering businesses during normal hours)
- 9764 Premise Checks (officer checking cursory checks of businesses after hours
- · Officers made three (3) misdemeanor and/or warrant arrests
- · Officers made one (1) felony arrest
- · Officers issued 86 written traffic citations (up from 46 last month)
- Officers issued 75 written traffic warnings (up from 35 last month)
- Officers issued 2 compliance (local ordinance) tickets
- . Officers handled an additional 564 calls for service and wrote 46 related reports
- . Twenty-five (25) trucks were weighed based on a suspicion of being overweight and fined accordingly

Investigations Division had the following activity

- . Closed sixteen (11) cases: 5 administratively, 2 Unfounded, 2 No complaint from SA, 2 other
- (12) Cases are awaiting review/charges from the State's Attorney · Added (6) new cases, including (3) child exploitation cases
- Conducted (5) Victim Sensitive Interviews with Will County Child Advocacy Center
- · Completed background investigations on (4) new-hire candidates

- Ten (8) officers received firearm training seventeen (19) drills, and nine (5) range days were utilized by visiting LE agencies.
- · Officers participated in a total of 96 hours of off-site training.
- · Each officer participated in 24 Lexipol daily training scenarios.
- · All members have completed one PLI online training course (approximately one (2) hour in length) on the topic of Racial Profiling, Implicit Bias, and Cultural Competency.

Administration:

- Worked with Police Commission on new hire list; two applicants passed for background issues, one was approved and issued a conditional offer of employment (Salazar)
- Completed and obtained NCMEC certification in Missing Kids Readiness Program
- Completed hiring process for Jacob Jasnosz. Sworn in 12/20/22.
- . Karl Jurgens approved and promoted to Sergeant. Sgt. Justin Dole move to Administrative Division.
- Accreditation Policy and Procedure modifications continues.
- · 2023 Schedule completed, including shift picks per MAP contract

Highlights - Continued

- Modernizing and standardizing policies and procedures.
- Completed a full review and disposal of records and evidence rooms.
- Held training and safety meetings with various groups and the public.
- Working to improve and increase cost-sharing of our gun range.

Truck Enforcement

- Expanded Truck Enforcement Program adding additional officers, training, and tools to the detail.
- Issued over \$300k in fines and violations in 2022.
- Partnered with local businesses to install signage on their property to reduce issues.

- Includes property maintenance codes and standards.
- Addresses new materials and technologies like solar, EV, PEX.

- Primary role is safety and compliance.
- Increases property values.
- Online records and tracking.

As we celebrate our past year's accomplishments and look toward the successes that lie ahead for our city, we reflect on the time spent in our neighborhoods and with our residents and businesses this past year learning about your most pressing issues. Many of you expressed a concern for better collaboration and communication between your units of government and the public. This publication is the direct result of those requests.

In 2022, the City welcomed several new department head level employees who took time to take stock of our assets and have started the planning process for future years' work. One of our accomplishments this year was the creation of a GIS system for classifying our streets. This program will help us determine which roads are in most need of repair, what type of repair is required and what the cost of those repairs will be. The information we retrieve from this system will help us plan road programs for each year moving forward.

Communication

- Collaborated with other local bodies on creating a direct-mailed newsletter to all residents.
- Increased social media presence and outreach to public.
- Performed SWOT planning sessions with local groups.
- Improved cities website, publishing of meetings, and increased government transparency and reporting.
- Have regular meetings and open communication with local taxing and governmental bodies and groups.

113.45 License required.

No person shall operate or conduct a public dance in the municipality without having obtained a license therefor as is provided herein.

('68 Code, § 113.225) Penalty, see Section 113.999

113.46 Application-Investigation-Fee.


- (A) Application for licenses shall be made in conformance with the provisions relating to licenses, and shall specify the location of the proposed dance or dances and the person or organization sponsoring the same.
- (B) No license shall be issued to a person who is not of good moral character, nor to a corporation or organization which is not represented in the municipality by a person of good moral character.
- (C) It shall be the duty of the chief of police to make or cause to be made an investigation into the character of each applicant and report the results of the investigation to the city clerk.
- (D) The annual fee for public dances shall be as provided in Section 113.02.

('68 Code, §§ 113.230 and 113.235) Penalty, see Section 113.999

113.47 Premises.

No person shall conduct a public dance in any hall or place which is not equipped with sufficient and adequate exits. No hall or building which is not provided with at least 2 exits of 4 feet or more in width shall be used for such purpose.

('68 Code, § 113.240) Penalty, see Section 113.999



- Connections to entire town and to area bike networks.






