#### Budget Impact: None

**History:** The City of Wilmington entered into a lease agreement with AT&T to construct a Cell Tower on City property at 601 E. Kankakee River Drive (part of PIN 03-17-25-200-015-0000). As was permitted within the lease agreement, AT&T assigned the lease to Vertical Bridge 500, LLC to construct the cell tower. In order for Vertical Bridge to build the tower, the City must grant easement to Commonwealth Edison to provide power to the cell tower. The attached Ordinance No. 23-10-03-01 provides for that easement, the plat for which is attached and labeled Easement Plat.

Staff and the City Attorney have reviewed the information before you and finds it to be in good form.

#### ORDINANCE NO.

#### AN ORDINANCE AUTHORIZING THE EXECUTION OF A GRANT OF EASEMENT BETWEEN THE CITY OF WILMINGTON AND COMMONWEALTH EDISON COMPANY (601 E. Kankakee River Drive, Wilmington, IL 60481; Part of PIN: 03-17-25-200-015-0000)

WHEREAS, the City of Wilmington (hereinafter referred to as the "City") entered into an Option and Land Lease Agreement (hereinafter referred to as the "Agreement") with New Cingular Wireless PCS, LLC (hereinafter referred to as "AT&T") to build a cell tower on the City's property located at 601 E. Kankakee River Drive, Wilmington, IL 60481; and

WHEREAS, After entering into the Agreement with the City, AT&T assigned its rights under the Agreement to Vertical Bridge 500, LLC (hereinafter referred to as "Vertical Bridge"), and Vertical Bridge intends to build a cell tower; and

WHEREAS, In order for Vertical Bridge to build a cell tower, the City of Wilmington must grant an easement to Commonwealth Edison Company to provide power to the cell tower; and

WHEREAS, City Council for the City of Wilmington finds its necessary and appropriate to grant an easement to Commonwealth Edison Company consistent with the Grant of Easement attached hereto as Exhibit A.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF WILMINGTON, WILL COUNTY, ILLINOIS, AS FOLLOWS:

#### SECTION 1. AUTHORIZATION TO EXECUTE EASEMENT

The City of Wilmington hereby approves the Grant of Easement, attached hereto as Exhibit A and by reference specifically made a part hereof, granting an easement to Commonwealth Edison Company, and authorizes and directs the Mayor to sign and for the Deputy City Clerk to attest to the Mayor's signature on the Grant of Easement.

#### SECTION 2. SEVERABILITY

This Ordinance and every provision thereof shall be considered severable, and the invalidity of any section, clause, paragraph, sentence, or provision of this Ordinance shall not affect the validity of any other portion of this Ordinance.

#### SECTION 3. REPEALER

All ordinances or parts of ordinances conflicting with any provisions of this Ordinance are hereby repealed.

#### **<u>SECTION 4</u>**. **<u>EFFECTIVE DATE</u>**

This Ordinance shall be effective after its passage, approval and publication in

## EXHIBIT A

#### GRANT OF EASEMENT

THE CITY OF WILMINGTON, ILLINOIS ("Grantor") in consideration of the sum of One Dollar and other valuable consideration, receipt of which is hereby acknowledged, hereby grant(s) and conveys to COMMONWEALTH EDISON COMPANY, an Illinois Corporation, (together with its licensees, successors and assigns, "Grantee"), an collectively, easement to construct, operate, repair, maintain, modify, reconstruct, replace, supplement, relocate and

remove, from time to time, poles, guys, anchors, wires, cables, fiber, conduits, manholes, transformers, pedestals, splice boxes, or other facilities used in connection with overhead and underground transmission and distribution of electricity, communications, sounds and signals (collectively, the "Facilities"), together with right of access to the same and the right, from time to time, to trim or remove trees, bushes, roots and saplings and to clear obstructions from the surface and subsurface as may be reasonably required incident to the grant herein given, in, over, under, across, along and upon the surface of property situated in Section 25, Township 33 North, Range 9, East of the Third Principal Meridian in Will County, Illinois (the "Property"), further described below:

# A 10' wide easement as being legally described and depicted on the "Easement Plat" attached hereto and made part hereof.

Obstructions shall not be placed over the Facilities or in, upon or over the Easement Area without prior written consent of Grantee, which consent shall not be unreasonably withheld, delayed, or denied; provided, however, that, notwithstanding the foregoing, so long as none of the following interfere with Grantee's rights granted herein, pavement, curbs, gutters, sidewalks, driveways, and concrete, may be permitted in the Easement Area. After installation of any Facilities, the grade of the Property shall not be altered in a manner so as to interfere with the operation and maintenance thereof.

Grantor shall have the right to continue to use and enjoy the Property so long as such use does not interfere with such Facilities as are set forth on Exhibit A and such use shall be subject to and consistent with the rights and easements herein granted to Grantee, and shall be exercised in such manner as not to interfere with the construction, operation, maintenance, patrol and use of the Facilities by Grantee.

In the event Grantee exercises its rights hereunder and the Property is damaged in connection therewith, Grantee shall, at its cost, repair the Property to a substantially similar condition that the Property existed prior to such damage.



Committee members have reached out to many other vendors to determine their availability and interest in Catfish Days 2024, and Zeiler Amusements is the only vendor responsive to our request.

At this time Staff is requesting a motion authorizing the City Administrator to execute a contract with Zeiler Amusements on review and approval of the City Attorney and at no cost to the City.

(I) Whereas the party of the first part agrees to furnish and present entertainment amusements, commonly known as Zeiler

Amusements, which amusements consists of moral refined attractions in Wilmington, Will County, Illinois on said dates 07/24/2024

through 07/27/2024 both dates inclusive. Under the following conditions and considerations: Zeiler Amusements agreeing to give

and pay the sponsor a percentage of the gross ride sales as follows, 25% of ride gross after generator fuel surcharge and general

liability insurance percentage is deducted off the top

Zeiler Amusements agrees to give and pay the sponsor \$50.00 for each concession operated by Zeiler Amusements, Zeiler Amusements is to have and hold exclusive rights from the sponsor on all inflatable and or mechanical amusement rides, carnival games and the following food items: Cotton Candy, Sno-Cones, Popcorn, Funnel Cakes, and Elephant Ears, Corn Dogs.

(II) In addition to the foregoing, and in consideration of the monies to be received from Zeiler Amusements the sponsor agrees to (check only those that apply)

() Furnish ticket sellers for all said shows and rides.

(x) Furnish space for and give access to said space in ample time to safely erect the entertainment amusements of Zeiler Amusements.

(x) Provide ample police/security protection for Zeiler Amusements and staff.

(x) Post, Hang, Distribute and Display all advertising furnished by Zeiler Amusements. Will supply 50 posters.

(x) Furnish Zeiler Amusements with all required, county and/or City Licensing.

(x) Furnish ample and secure parking for surplus vehicles and trailers.

(x) Have available on the day of arrival Restroom facilities or portable toilet for Zeiler Amusements employees.

(x) Provide full access to ample electrical current and water needed by Zeiler Amusements.

(x) Office and employee house trailers.

(x) Concession trailers.

(x) Electrical power,generators, power drops for the midway attractions will be provided by Zeiler Amusements.

(III) This contract is for a term of 3 Year(s) and may be withdrawn by Zeiler Amusements within 15 days of presentation.

(IV) Zeiler Amusements reserves the right to designate location of the rides, concessions and equipment in the allotted space and replace or substitute said rides, as deemed necessary.

- **Discussion:** There are four light poles that surround the fishing and skating pond at North Island Park. Two of the four poles, as well as the electrical panel's foundation, are located in the water when the water level is at its highest. The four poles belong to ComEd, but all of the equipment (lights, secondary wiring, electrical panel etc.) belong to the City of Wilmington. ComEd will move the two poles but we are responsible to move the equipment. Clennon Electric has provided a quote to move the existing equipment and replace what is needed to make this area safe for lighting again. The power to the lights is currently disconnected at a distant ComEd power pole. This is not a budgeted request.


