# <u>Hold-Harmless Agreement</u> For Charitable Street Solicitation

*(name of charitable organization)* and all of those soliciting (hereinafter referred to as õAll Membersö) do hereby request permission from the City of Wilmington to solicit at the intersection of State Highways 102 and 53 in the City of Wilmington. All Members who will be soliciting have signed this Agreement.

All Members have been provided a copy and read and understood and agree with all of the terms contained in

- a) the City Ordinance regulating soliciting;
- b) the State Statute regulating soliciting; and
- c) this Agreement

All Members agree to obey all ordinances, statutes, and laws while soliciting. All Members fully realize and understand that soliciting on the public rights of way, by its very nature, can and will, in all probability, involve some danger, and that situations may arise which could result in personal injury or death, and all Members freely and voluntarily accept and assume these risks.

All Members do hereby release and forever discharge and covenant to hold harmless, for themselves and their heirs, personal representatives, administrators, successors, and assigns, the City of Wilmington, and any of their officers, agents or employees, from any and all liability for any and all claims, demands, suits, actions, injuries, damages, costs, losses, or liability whatsoever or otherwise related in any way or occurring as a consequence of soliciting on the public rights of way, whether through negligence or otherwise.

All Members and the charitable organization further agree to hold harmless and fully indemnify the City of Wilmington and any and all of their officers, agents or employees, whether through negligence or otherwise, from any and all third party claims, demands, suits, actions, injuries, damages, costs, losses, or liability whatsoever or otherwise related in any way or occurring as a consequence of soliciting on the public rights of way, said costs to include damages, costs, attorneys fees, expert fees, settlements, liability and losses of any kind, whether or not such claims or actions are rightfully brought or filed.

The charitable organization agrees to reimburse the City for any expenses, attorney s fees, or costs incurred in the enforcement of any part of this Agreement.

The charitable organization has provided written evidence that it has obtained insurance providing coverage for bodily injury, as well as property damage liability, in the amount of \$1,000,000.00 for any individual and \$1,000,000.00 for any occurrence, and such evidence shall name the City of Wilmington as an additional insured.
